I understand the Co-op is a mix of residential and commercial interests and can imagine both those are affected at the moment, and you're looking at the downside with realism - let's hope that things improve before long.

While the Co-op incomes are uncertain, you may also have looked at the costs that the Co-op runs – there could be some relief on utilities available to you, and perhaps you've considered what might be done with the financial costs. If the investor were flexible and if the bank loan were adjusted, then the financial liabilities could change. At Triodos Bank we're open to requests for Capital Repayment holidays for 12 months. Do please let us know if this would make a difference, while you are evaluating your options together.





Overlapping and interconnected

- New worker co-op sit within the co-op system each performing specific function
- Elements in this system are connected by the sharing of knowledge, information and surplus
- Even if one element were to fail any value accumulated by it would be retained within the system, it is not lost. E.g. of Dragons

Co-op universe

- All independent, autonomous enterprises have a specific function and contain their own risk.
- There is no risk of contagion
- Wider secondary co-op provides a container for the independent co-ops etc to exist with creating a co-operative ecosystem of its own
- This model can easily interlink or overlap with other nearby co-operative ecosystems
